NOTICE FOR THE POST OF EXECUTIVE DIRECTOR

- i. NBE is an autonomous organization established by the Ministry of Health and Family Welfare with main objective to conduct post-graduate examinations in the discipline of Modern Medicine and other allied sciences at the national level;
- ii. The details of the job and other particulars are given below:
 - a) The Executive Director is expected to provide both academic as well as administrative leadership to the Board in its various activities.
 - b) The post is in the Pay Band – IV of Rs. 37,400-67,000 + Grade Pay of Rs. 10,000/- plus NPA and such other allowances as per Central Government Rules.
 - c) Eligibility Criteria:

Essential:

 - (1) A recognized medical qualification included in the first or second schedule or part II of the third schedule (other than licentiate qualifications) to the Indian Medical Council Act 1956. Holders of educational qualifications included in part II of the third schedule should fulfill conditions stipulated in section 13(3) of the IMC Act.
 - (2) Post graduate qualifications mentioned in schedule of the IMC Act or equivalent.
 - (3) At least 20 years standing in the profession out of which 12 years teaching experience at the post graduate level in the faculty position after post graduation out of which 12 years teaching experience at post graduate level in a faculty position out of which 3 years as Professor & Head/Director/Professor/Dean of a medical college or its equivalent.

Or Three years of experience as Special Director (Medical) in the National Board of Examinations.

Desirable: Training in medical education technology with at least five publications in the field of medical education. Experience as a project director /co-director on a project in the field of medical education, wide knowledge in the modern evaluation techniques including generation of MCQ's, analysis of performance of the candidates.
 - d) Age: not exceeding 55 years.
 - e) Tenure: The post is on fixed tenure basis with one year probation.

1. Applicant must be Citizen of India
2. Candidates must possess the prescribed educational qualifications and experience as on the last date of application.
3. Mere possession of minimum qualification and experience does not entitle candidate to be called for interview.
