**Subject: Schedule of Final (Mop-up) Round** of the online Centralized Merit Based Counseling for admission to **Sponsored DNB (Post MBBS) courses** for 2022 admission session. Refer Public notice dated 03-11-2022.

1. In terms of Para 5.3 of the Counseling handbook for Sponsored DNB (Post MBBS) counseling, NBEMS shall be conducting the **Final (Mop-up) Round** of the online Centralized Merit Based Counseling for 2022 Admission Session for **Sponsored DNB (Post MBBS) courses**. The schedule for the Final (Mop-up) round counseling is as follows:

ii.	Filling of Choices/options for the Final (Mop-up) Round of counseling	27 <sup>th</sup> – 29 <sup>th</sup> January, 2023 (Up to 05:00 PM)
iii.	Processing of the Allotment	30 <sup>th</sup> January, 2023
iv.	Result of the Allotment	31 <sup>st</sup> January, 2023
v.	Physical joining at the allotted hospital	31 <sup>st</sup> January to 7 <sup>th</sup> February, 2023

2. Only the registered candidates who have not been offered any seat during the **First** and **Second** round of Counseling, will be eligible for the **Final (Mop-up) Round** of Counseling (Refer para 5.3 (2) of the Counseling handbook). Candidates who have been allotted any Sponsored DNB (Post MBBS) seat in any of the two rounds of Counseling, but have failed to join the allocated institute shall also be ineligible for participation in Final (Mop-up) Round of Counseling.
3. Candidates are also advised to carefully go through the Flowchart indicating the process of allotment of Sponsored DNB (Post MBBS) seats in the Final (Mop-up) round.
