**C.M. No.31318/2017 (interim relief)**

Petitioner has successfully completed her PG Diploma (2 year course). She had appeared in the PDCET Entrance Examination for completing her course in the DNB (2 year course). The result of the PDCET was declared on 04.8.2017. Petitioner's result was withheld for the reason that she had not submitted her final degree of the PG Diploma (2 year course); she had only given her provisional certificate.

Contention of the petitioner is that her result was declared by respondent no.2/Rajiv Gandhi University of Health Sciences only on 11.7.2017 and this the cut off date of respondent no.1 that all original degrees/certificates had to be submitted by 30.6.2017; the deadline which could not be met by petitioner for reasons beyond her control. Her submission is that in view of the subsequent notification of

respondent no.1 dated 12.8.2017 the admission process for the DNB PDCET- Emergency Medicine (2 year course) first counselling is now scheduled for 14.9.2017.

Admittedly, this is the first counselling session which would be conducted by respondent no.1. Learned counsel for respondent points out that since the petitioner was not able to submit her original documents by 30.6.2017, she has rightly been held ineligible to participate in the counselling.

This Court is not in agreement with the submission of the respondent; the reason for non-submission of the original certificates was for reasons beyond her control as her result was declared by respondent no.2 only on 11.7.2017. It is also not in dispute that the petitioner had forwarded (through e-mail) her original documents to the respondent on the same date i.e. 11.7.2017.

Petitioner is permitted to participate in the round of counselling which is scheduled for 14.9.2017.

Interim application is disposed of.
