- Candidates who have been allotted a confirmed seat during the online counseling (1st or 2nd or 3rd Round) are NOT eligible to participate in the Final Round of Counseling irrespective of their joining/non-joining/resignation from the seat already allotted to them.

• It is mandatory that the candidates who wish to participate in the Final Round of counseling

have to produce the *Counseling Participation Letter* at the time of counseling downloaded from the website mentioned at the above link.

- All the eligible candidates appearing for final round of counseling also required to produce all the documents/certificates, in original, as mentioned in the Handbook of counseling for July 2018 admission session, failing which the candidate shall not be allowed to participate in the final round of counseling.
- Candidates are required to submit One-year course fee of Rs. 80000/-(Rupees Eighty Thousand Only) as Demand Draft (DD) in favour of National Board of Examinations payable at New Delhi while opting the seat in the final round of counseling, failing which the seat opted by them, shall not be allotted.
- The Indicative seat matrix for the Final Round of counseling shall be made available on NBE website shortly. Final Seat matrix shall be notified at the NBE website and the Counseling venue prior to the commencement of the Final Round of counseling.
- The candidates opting confirmed seats during the Final Round of counseling can download their allotment letter from the Counseling website https://counseling.nbe.edu.in/.
- The candidate allotted with a confirmed seat during the Final Round of counseling has to join the allotted institute within the prescribed time (i.e. by 05.11.2018) mentioned in the counseling schedule available on the website.
- Joining of the candidate is subject to verification of original documents and eligibility for admission to DNB (Post Diploma) as per NBE guidelines published in the Information Bulletin & Handbook for Admission to Diplomate of National Board Post Graduate Courses (Post Diploma) July 2018 Admission Session.
- Candidates are required to make their own arrangements for boarding & lodging. Travel cost to appear in the Final Round of counseling shall be borne by the candidates themselves.
- Candidates are advised to report to the counseling venue at the prescribed time. Candidates reporting after the prescribed time are liable to miss their turn in the Counseling/non-participation. NBE shall not be responsible for any delay in arrival due to any reason. No claim in this regard shall be entertained. NBE reserves its rights to take appropriate decisions in cases of late reporting by the candidates. However, no candidate under any circumstances shall be allowed to disrupt the existing flow of candidates for counseling if he/she reports late on any ground.
