I INTRODUCTION

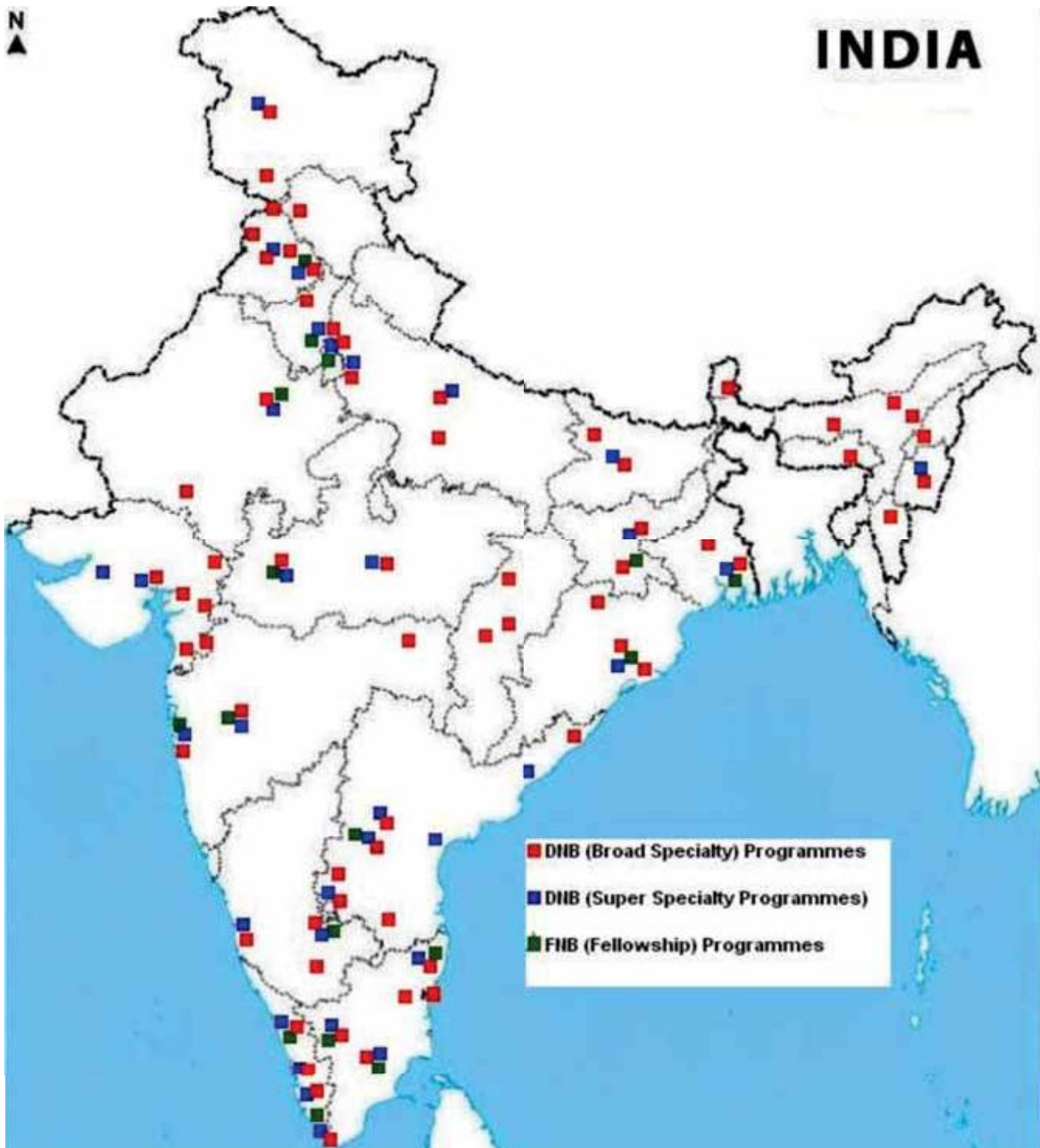
1. Since 1982 NBE has been functioning in the field of post graduate medical education. NBE is the only examining body of its kind in the country in the field of post graduate medical sciences. Continuing evaluation of quality and validity of the measurement mechanism and standards of examinations by constant interaction with experts in various disciplines of modern medicine and allied specialties are among its important activities.
2. NBE conducts examinations in 69 disciplines and subspecialties of modern medicine which includes DNB programme in 30 broad and 22 super specialties. NBE has accredited approximately 450 institutions/ hospitals in public and private sector all over the country. During the year 2013-14, the Accreditation committee recommended accreditation to 45 hospitals for Broad specialty, 34 hospitals for Super specialty and 20 hospitals for FNB courses accounting to 96 seats for broad specialty, 91 seats for Super specialty and 50 seats for FNB courses. Also renewal was granted to 318 hospitals for Broad specialty, 39 hospitals for Super specialty and 32 hospitals for FNB courses accounting to 407 seats for Broad specialty, 133 for Super specialty and 117 for FNB courses.
3. National Board is also conducting Fellowship programme in 17 sub-specialties for MD/MS/DNB doctors who have completed their training in the concerned specialties. Selection to the fellowship programme is based on an entrance test and admission to the courses is through centralized merit based counseling.
4. NBE provides a common national standard for evaluation of minimum level of attainment of the knowledge and competencies of postgraduate and postdoctoral training. Well equipped centers have been identified and accredited by NBE in the concerned specialties to provide excellent training infrastructure and faculty for the candidates. Diplomate Qualifications awarded by NBE have established benchmarks of high quality in the field of medical education in the country.
5. NBE is now conducting most of its Post Graduate Medical Entrance Examinations through Computer Based test delivery for a large candidate population. CBT implementation has not only made the NBE examination system more consistent and secure but also more convenient for the candidates. It not



- only allows flexible scheduling and faster score reporting but also provides ease of access to candidates (especially to differentially abled candidates).
6. The Diplomate/Fellow qualifications awarded by the National Board of Examinations have been equated with postgraduate degree and postdoctoral level qualifications of universities by the Government of India, Ministry of Health and Family Welfare.
 7. The holders of NBE qualifications are eligible to be considered for specialists' posts in any hospital and for teaching positions at academic institutions. The holders of NBE qualifications awarded after an examination i.e. DNB, are eligible to be considered for specialists post / faculty in any hospital including training /teaching institution on a teaching post / as faculty members / teacher / Assistant Professor/ lecturer.
 8. Over the years NBE's research engagements have also increased significantly. NBE has consistently promoted collaborations with various national and international agencies/bodies of repute in the field of medical education and research to promote and provide a broader range of both technical as well as academic expertise to enrich the various DNB programmes being conducted by the board.
 9. NBE in collaboration with Children's Heart Link, US, and People4People, India, are organizing interactive virtual teaching program for pediatric cardiology candidates to deliver a comprehensive and more widely accessible quality teaching program through CME sessions consisting of didactic webinars and Web discussions and quizzes.
 10. NBE is also regularly conducting Faculty Development Workshops wherein the faculty is sensitized to carry out effective teaching, training and mentoring activities for DNB /FNB candidates.
 11. Considering the emerging need to increase the pool of competent and skilled specialists and sub specialists so as to cater to the healthcare needs of the society and community at large, NBE has decided to introduce the following additional DNB & FNB programmes:
 - DNB Thoracic Surgery
 - Fellowship in Pediatric Gastroenterology
 - Fellowship in Sports Medicine

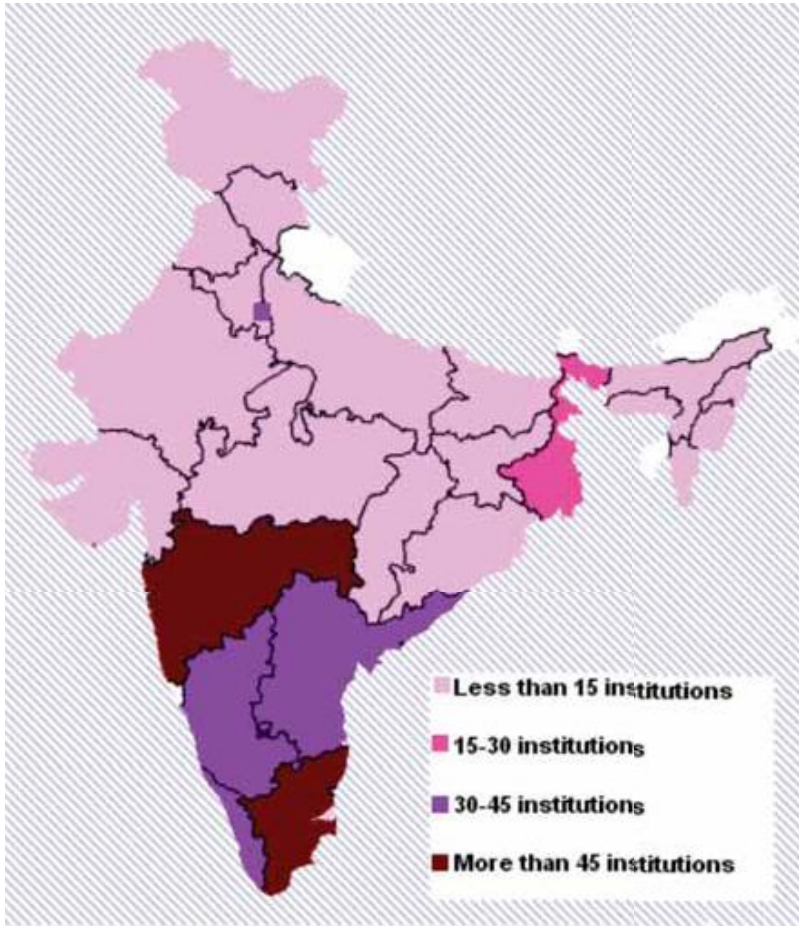


Presence of NBE: Bird's Eye View





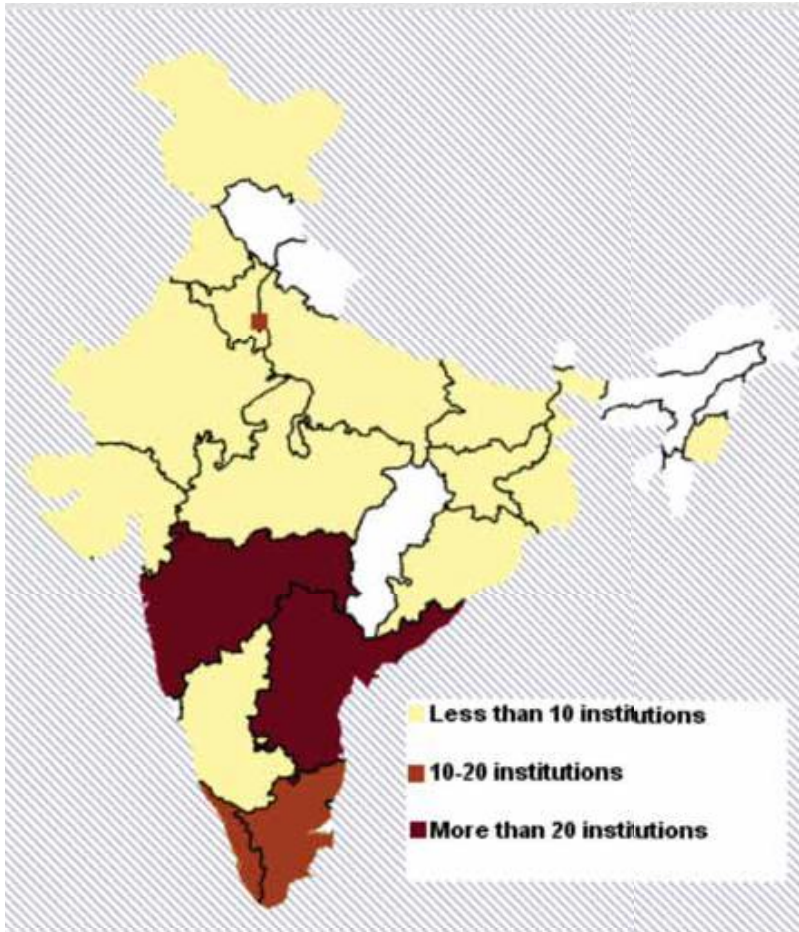
State Wise Distribution of NBE Accredited Institutions for Broad Specialty Programmes

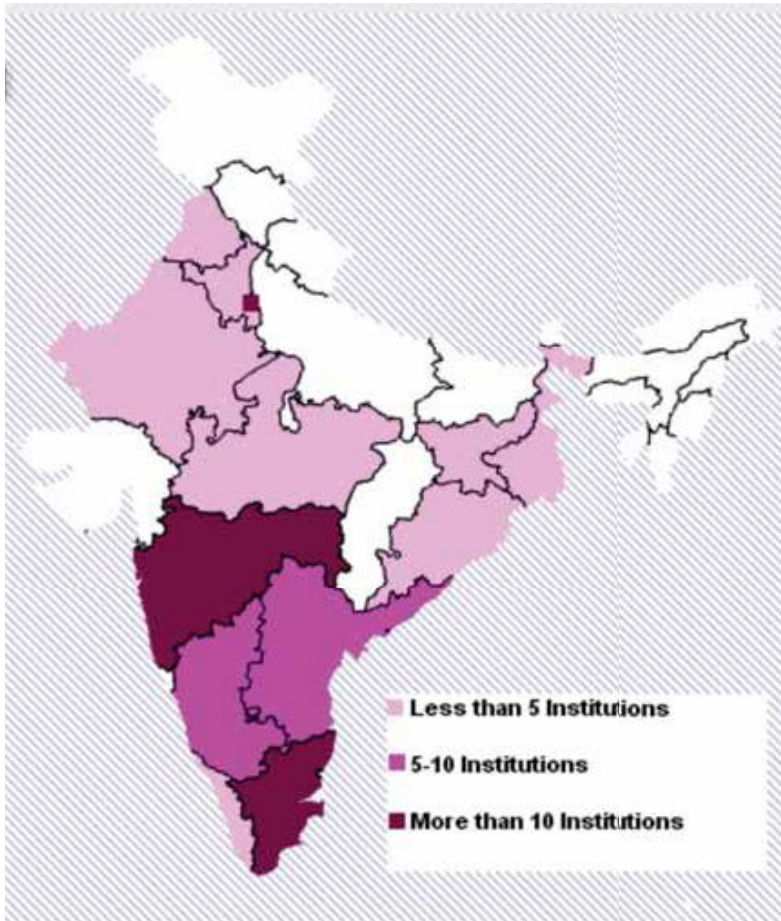
State Wise Distribution of NBE Accredited Institutions for Super Specialty Programmes

III MEETINGS OF THE GOVERNING BODY

During the period, Two meetings of the governing body of NBE were held at New Delhi. Illustrative decisions taken during these meetings are as follows:

1. Approval for conducting AIPGEE 2014
2. Grant of accreditation to various hospitals.
3. Introduction of newer disciplines as :
 - a. DNB Thoracic Surgery,
 - b. Fellowship in Pediatric Gastroenterology and
 - c. Fellowship in Sports Medicine
4. Approval for fee revision
5. Approval for seat enhancement
6. Approval of Audited Annual Accounts and Audit Report
7. Consideration of various cases as referred by competent courts.



IV EXECUTIVE SUMMARY

1. In the year 2013-14 National Board of Examinations completed 32 years of its inception as an independent autonomous organization in the field of Post Graduate Medical Education. During the current year, NBE continued its progressive journey towards excellence in post graduate medical education, assessment and research with greater enthusiasm and equitable participation. National Board of Examinations during the year conducted DNB CET, CET-SS, PD-CET, Screening Test, AIPGMEE, Karnataka PGET, Jharkhand PGET, DNB Final, Fellowship Entrance Examination, and Fellowship Exit Examination for a total of 153,753 candidates.

Total Candidates who took NBE examinations: 153,753

2. DNB Final examination and Fellowship Exit examination were conducted across various centers in the country by NBE. Improvements in assessment methodology backed by research in assessment were instrumental in achieving excellence. During the year 2013-14, a total of 3185 candidates qualified DNB Final Examination for broad specialties, 316 candidates qualified DNB Final Examination for Super Specialties and 104 candidates qualified Fellowship Exit examination.

Total Candidates who qualified DNB and FNB final examinations: 3605

3. DNB CET July 2013 (in which 20686 candidates appeared), DNB CET January 2014 (in which 31667 candidates appeared), DNB CET SS January 2014 (in which 2179 candidates appeared) and DNB PD CET (in which 2801 candidates appeared) were all conducted on Computer Based Test (CBT) Mode. 881 candidates appeared for Fellowship Entrance Test January 2014 session.

Total Candidates appeared in DNB CET; DNB CET SS; FET; PDCET- 58214

4. All India Post Graduate Medical Entrance Examination was conducted on All-India Basis for admission to All India 50% quota MD/MS/Diploma Seats – 2014 Admission Session (except for colleges located in Jammu & Kashmir and Andhra Pradesh) as a Computer Based Test from 25th November – 6th December 2013 in 38 cities and 71 test centres across the country. The candidates who were registering for AIPGMEE were provided with the option of choosing their examination centre, date and time through the online registration & scheduling system. A total of 70073 candidates



appeared for the AIPGMEE online examination out of which 44239 candidates passed the examination. The test comprised of 300 Multiple Choices, single correct response questions in English language only.

5. **Karnataka PGET:** During the year 2014, NBE conducted Karnataka PGET Medical and PGET Dental examinations for Selection and Admission to Post Graduate Medical and Dental Degree and Diploma Courses in the state of Karnataka. PGET Medical examination was conducted from 11th February to 15th February, 2014 in 11 cities. PGET Dental examination was conducted on 15th February, 2014.

6. **Jharkhand PGET 2014:** NBE also conducted Jharkhand PGET examination for admission to PG Degree and Diploma courses in Medical subjects for the State Quota seats/ Jharkhand Government Quota seats in Government Medical

Colleges/Institutions within the State of Jharkhand from 11th February to 15th February, 2014. A total of 753 candidates appeared for the examination out of which 575 candidates passed the examination.

7. During the year 2013-14, two meetings of the Accreditation committee were held. The committee recommended accreditation to 45 hospitals for Broad specialty, 34 hospitals for Super specialty and 20 hospitals for FNB courses accounting to 96 seats for broad specialty, 91 seats for Super specialty and 50 seats for FNB courses. Also renewal was granted to 138 hospitals for Broad specialty, 39 hospitals for Super specialty and 32 hospitals for FNB courses accounting to 407 seats for Broad specialty, 133 for Super specialty and 117 for FNB courses.

Total seats available in DNB and FNB Courses: 4235

8. Admissions to various DNB & FNB courses are being done through Centralized merit based counseling conducted by NBE. For DNB CET-July 2013 session, 1471 candidates attended the counseling and 663 candidates registered. For DNB PDCET July 2013 session, 783 candidates attended the counseling and 417 candidates registered. For DNB PDCET January 2014 session, 871 candidates attended the counseling and 612 candidates have registered till now. For DNB CET SS



January 2014 session, 710 candidates attended the counseling and registration process is in process. For NBE FET January 2014 Session, 335 Candidates attended the counseling and 183 candidates have registered till now.

9. NBE welfare Fund was created and registered under Societies Registration Act XXI to provide a fall back institutional mechanism and undertake activities related to the welfare of all its members and stakeholders. In addition to existing

committees under the NBE Welfare Fund i.e. namely Loan and Advance Committee, Finance Committee, Socio Cultural Committee, Mess Management Committee and Committee for Housing Society, two new committees were constituted namely Sports Committee, and General Welfare Committee for Members. Respective committees continued their activities and various events were organized for the members. The annual report for the society with audited statement of accounts was also prepared and approved as per procedure.

10. NBE maintained interface with more than 4100 faculty members and specialty experts from leading medical institutions of the country.

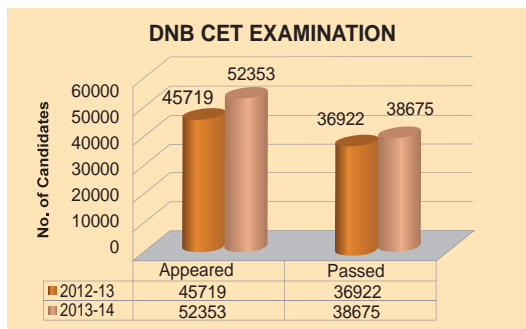
V ACTIVITIES UNDERTAKEN DURING THE YEAR

1. EXAMINATIONS

i **DNBCET** CENTRALIZED ENTRANCE TEST (CET):

There is a common CET for entry to all DNB Broad specialty courses. Candidates who have completed their compulsory internship after graduation are eligible to take the CET examination. DNB CET is of the MBBS exit standard. This is a computer based objective type test of three hours duration comprising of 180 multiple choice questions.

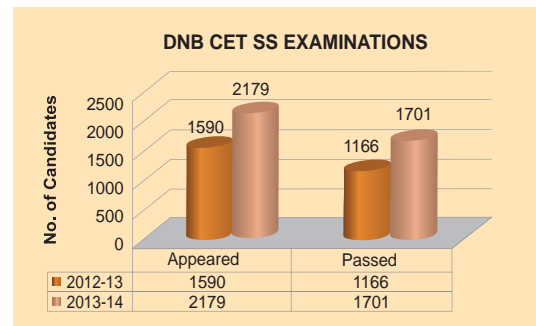
During the year 2013-14, 52353 candidates appeared out of which 38675 candidates passed the CET examination. There is 15% increase in the number of applicants for the DNB-CET during 2013-14.



ii **DNBCETSS** CENTRALIZED ENTRANCE TEST (SUPER-SPECIALITIES)

Entrance to various to post MD/MS/DNB Super Specialty courses is done through CET-SS entrance examination. Candidates in possession of Post Graduate Qualification are eligible to take the CET-SS examination.

During the year 2013-14, 2179 candidates appeared in CET-SS out of which 1701 candidates passed the CET-SS examination. There is an increase of 37% in the no. of aspirants for CET-SS.

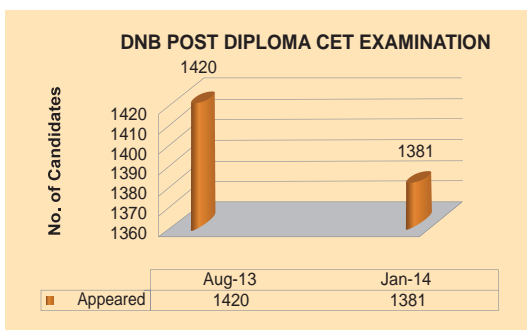




iii DNB PD CET CENTRALIZED ENTRANCE TEST (POST – DIPLOMA) :

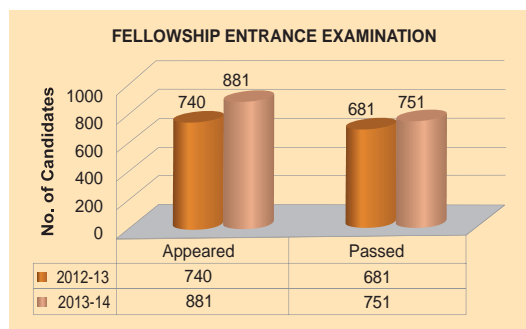
The Post Diploma CET is an entrance examination for entry to the DNB Broad Specialty secondary seats. Candidates having recognized Post Graduate Diploma qualification can apply for post Diploma-CET (PD-CET) Examination in the same Broad Specialty.

During the year 2013-14, a total of 2801 candidates appeared for the PD-CET examination in August 2013 & January 2014.



iv FELLOWSHIP ENTRANCE TEST:

This examination is held once in a year in the month of January for entry to fellowship courses. During the period under report, 881 candidates appeared and 751 candidates passed the fellowship Entrance Examination. There is an increase of approx 19 % in number of aspirants and the fellowship entrance test.





v **DNB**FINAL EXAMINATION:

Candidates registered with NBE as a DNB trainee or in possession of MD/MS in the concerned specialty can appear in the DNB Final Examination after completing their requisite training. Final theory examination consists of 4 papers of 3 hours duration each consisting of

structured short notes types of questions. Candidates successful in the DNB Final Examinations are eligible to appear in DNB Final Practical Examination. During the year 2013-14, practical centers were engaged by NBE. The specialty wise results for the year 2013-14 for DNB Final Examinations is given below:

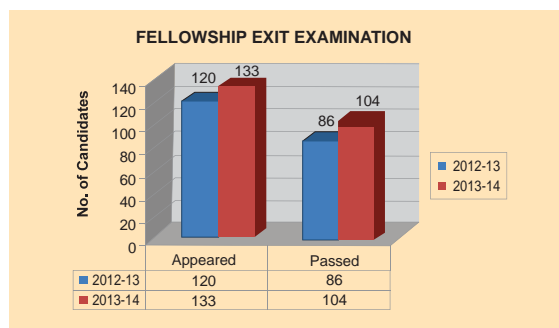

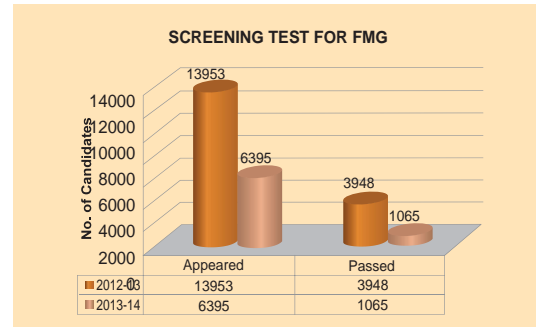


vii SCREENING TEST FOR FOREIGN MEDICAL GRADUATES:

The Government of India has entrusted the conduct of Screening Test under Screening Test Regulation 2002 for the candidate who have undergone medical training abroad to the National Board.

The test is conducted as per the scheme approved by Hon'ble Supreme Court of India in March and September every year.

During the year 2013-14, 6395 candidates appeared out of which 1065 candidates passed the FMG examination.

viii AIPGMEE (2014 Admission Session):

National Board of Examinations conducted the All India Post Graduate Medical Entrance Examinations for Admission to MD/MS/Post Graduate Diploma Courses 2014.

The National Board of Examination has been approved by Hon'ble Supreme Court to conduct a competitive entrance examination on All-India Basis for admission to All India 50% quota MD/MS/ Diploma Seats – 2014 Admission Session (except for colleges located in the state of Jammu & Kashmir and Andhra Pradesh). The entrance examination are governed by the rules and regulations specified by the Ministry of Health and Family Welfare/ Directorate General Health Services, Government of India and orders of Hon'ble Courts for entry to 50% All India Quota.

Duration of the courses:

MD/MS: Three years from the date of admission after completion of compulsory rotating internship.

Diploma: Two years from the date of admission after completion of compulsory rotating internship.

The scheme for selection of candidates for admission to All India 50% quota MD/MS/ Diploma Seats – 2014 Admission Session shall be applicable to all Medical Colleges/Institutions throughout the country and no Medical College/Institution shall hereafter conduct competitive entrance examination of its own for these seats on all-India basis, except the States of Jammu & Kashmir and Andhra Pradesh which have been excluded by the Hon'ble Supreme Court of India vide their judgement dated 21.07.1986 (Writ Petition (Civil) no.



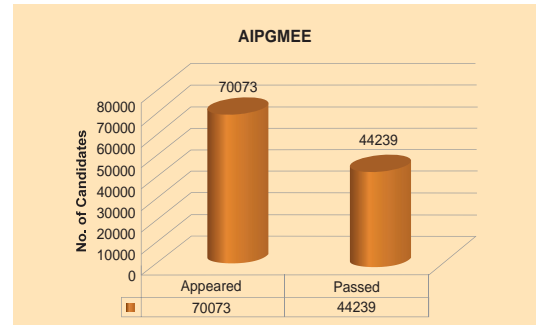
348-352 of 1985 in the matter of Dr. Dinesh Kumar & ORS vs Moti Lal Medical College Allahabad & ORS). Therefore, the students having passed their MBBS examination from any Institution in these two States shall not be eligible to participate in the 50% All India Competitive Entrance Examination for selection of candidates against these seats.

Candidates who are in possession of MBBS degree or Provisional MBBS Pass Certificate recognized as per the provisions of the Indian Medical Council Act 1956 and possessing permanent or provisional registration certificate of MBBS qualification issued by the Medical Council of India or State Medical Council and having completed their one year of internship or likely to complete the internship on or before 31st March 2014, were eligible to apply for AIPGMEE 2014 session through online application system.

The test comprises of 300 multiple choice, single correct response questions in English Language only.

The AIPGMEE 2014 examination was conducted as Computer Base Test (CBT) from 25th November – 6th December, 2013, in 38 cities and 71 test centers across the country.

During the year 2013-14, a total of 70073 candidates appeared for the AIPGMEE examination in November - December 2013 out of which 44239 candidates passed the examination.



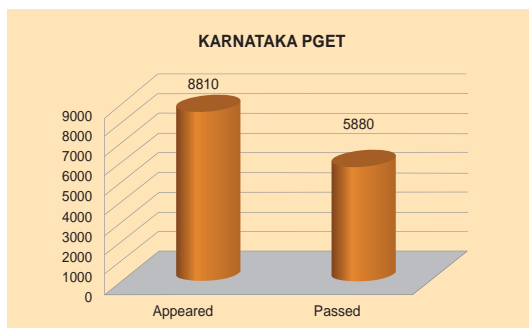
ix KARNATAKA PGET 2014

The Karnataka Post Graduate Entrance Test – 2014 (PGET 2014) is the test prescribed for the purpose of determining the eligibility for admission of students to PG Degree and Diploma courses in Medical and Dental subjects for the State Quota seats in Karnataka Government Colleges and Institutions and Karnataka Government Quota seats in Private Medical and Dental Colleges/Institutions and Deemed Universities within the State of Karnataka for the academic year 2014-15.

The test was conducted as computer based test during the testing window i.e. 11th -15th February, 2014 across 11 cities and comprised of 200 Multiple Choices, single correct response questions in English language.



A total of 8810 candidates appeared for the examination out of which 5880 passed the examination.



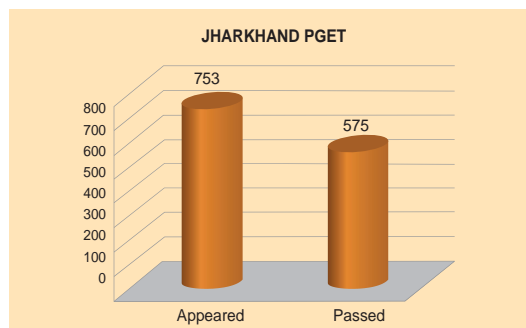

The Post Graduate Entrance Test-2014 (PGET 2014) is the test prescribed for the purpose of determining the eligibility for admission of students to PG Degree and Diploma courses in Medical subjects for the State Quota seats/Jharkhand Government Quota seats

in Government Medical Colleges/Institutions within the State of Jharkhand, for the academic year 2014-15.

The test was conducted as computer based test during the testing window i.e. 11th -15th February, 2014 and comprised of 200 Multiple Choices, single correct response questions in English language only.

A total of 753 candidates appeared for the examination out of which 575 passed.

4. POST DOCTORAL FELLOWSHIP PROGRAMMES:

NBE is providing professional advancement opportunities to medical postgraduates in the form of Fellowship Programmes in 17 sub specialties for further development of skills and competencies in their specialty areas. This 2 year fellowship Programme is specifically tailored to provide advanced training of highest quality and to broaden the educational experience of post graduate medical practitioners.

Well equipped centers, after due procedure have been identified in the concerned specialties for imparting hands on training. Candidates with

DNB/MD/MS/ DM/MCH qualification in the concerned specialty are eligible to pursue NBE fellowship training. Selection is based on an entrance test and centralized counseling.

The trainees go through a structured training programme, maintain performance record books and undergo examination at the end of the training. Successful candidates are awarded the fellowship of National Board at the annual convocation. NBE is the prime national level organization that has set a mechanism for imparting teaching and training in the sphere of higher medical education at various hospitals/ institutions in the public or private sector. There are many hospitals/ institutions in the public sector, Armed forces and in private sector all over the country with adequate infrastructure and clinical resources that can be gainfully deployed for PG training. NBE encourages the tapping of this rich clinical resource available in the country for training and teaching in higher medical education. Care is taken to ensure highest quality of training, through a mechanism of inspection, monitoring and review on the basis of guidelines framed by experts.

- NBE grants accreditation for DNB

courses to hospitals in various Broad and Super specialties. NBE has laid down norms for recognition of hospitals /institutions, which seek to train candidates.

- During the year 2013-14, two meetings of the Accreditation committee were held. The committee recommended accreditation to 45 hospitals for Broad specialty, 34 hospitals for Super specialty and 20 hospitals for FNB courses accounting to 96 seats for broad specialty, 91 seats for Super specialty (Including 2 seats for direct 6 years course) and 50 seats for FNB courses. Also renewal was granted to 138 hospitals for Broad specialty, 39 hospitals for Super specialty and 32 hospitals for FNB courses accounting to 407 seats for Broad specialty, 133 for Super specialty (Including 26 seats for direct 6 years course) and 117 for FNB courses.

6. TRAINING & MONITORING

- i Continuing Medical Education Programme/ Workshops:** National Board of Examinations in order to undertake capacity building and strengthening of the Post Graduate Medical Education in the country regularly conducts Continuing Professional Development programmes in the form of Continuing Medical Education Programme/ Workshops/seminars for post graduate trainees, faculty and specialists/ consultants and practicing professionals to keep their knowledge and skills abreast with the recent advances and to maintain and improve their performance standards. During the year under report, a total of 48 CME's/ Workshops were conducted by NBE.
- **Clinical Workshops/ CME's:** NBE conducts workshops in various clinical disciplines for enhancing expertise of candidates in modern and evidence based practices for patient care and clinical management. During the year under report, 11 such clinical workshops were conducted across the country as follows:

 - *Current Clinical Practices In Infectious Disease. NBE, Dwarka, Delhi*
 - Workshops on Research Methodology - NBE considers research as an integral part of DNB training. With the aim to strengthen research and facilitate capacity building in research methodology. NBE periodically conducts workshops on research methodology protocol writing and thesis writing. NBE has entered into strategic partnerships with leading medical and research institutions in the country for delivery of these



workshops. During 2013-14, 36 workshops on “Thesis Research & Protocol writing” were organized all over the country for the trainees.

- **Knowledge Assessment:** NBE also conducts knowledge assessment based workshops aimed at developing comprehensive expertise of candidates in writing theory exam. A workshop on the topic “How to prepare for DNB Medicine theory & practical examination” was organized with engagement of various experts on 8th- 9th July, 2013 at St. John's Medical College Hospital, Bangalore

ii E-learning –

- **Satellite Education:** Satellite based interactive sessions were conducted using television broadcast on Gyan Darshan Channel every Thursday. In the year 2013-14 approximately 205 Teleconferencing sessions were conducted by National Board of Examinations delivering a broadcast of 171 hours of programme. These sessions provide two way audio communication and one-way video communication between the faculty and the DNB students and it is also available on DTH Platform.
- **Gyan Vani (Radio FM):** NBE also conducts interactive sessions on FM Radio every Thursday on Radio Gyan Vani. This transmission is available

all over India. The Radio sessions provide an economical and convenient access for the Post Graduate trainees across various hospitals to eminent faculty members and to various important topics of the curriculum. During the year 2013-14, 35 sessions were held delivering 35 hours of programme.

- iii **Learning Material (DVD/CD):** NBE has also set up a repository of electronic, content covering 15 specialties available in various volumes in the form of DVD's. These cover a wide range of issues as a part of the Post Graduate curriculum for modern medicine from common topics to esoteric areas of knowledge which otherwise are not easily available as learning resource. During this year a total of 502 volumes of DVDs were made available to the medical institutes and post graduate candidates.

- iv **Local Appraisal:** The purpose of local appraisal is to further improve the quality of training, assess the training infrastructure for the DNB candidates and also assist the local institutions to develop into an enter of academic excellence. This would further add value to the services being rendered in these accredited hospitals/ institutions. During the year 2013-14, 1511 assessors were



appointed for the appraisal of hospitals/ medicals institutions across the country. Feedback on shortcomings observed and suggestions for further improvement were also communicated to the concerned hospitals and DNB Trainees for further improvement.

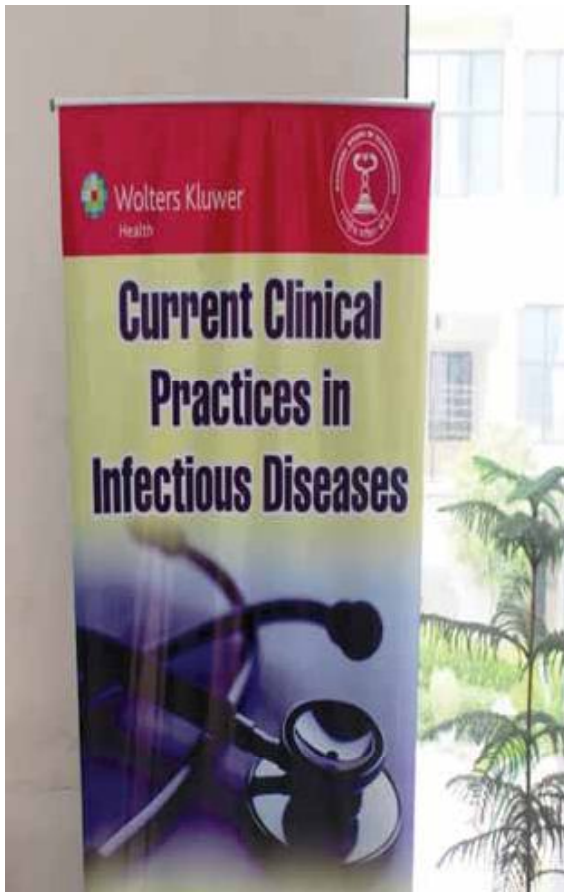
- v **SMS Alert:** NBE is sending latest information regarding Exam/ Counseling/CME/ Results and other

CME/Workshops at a Glance

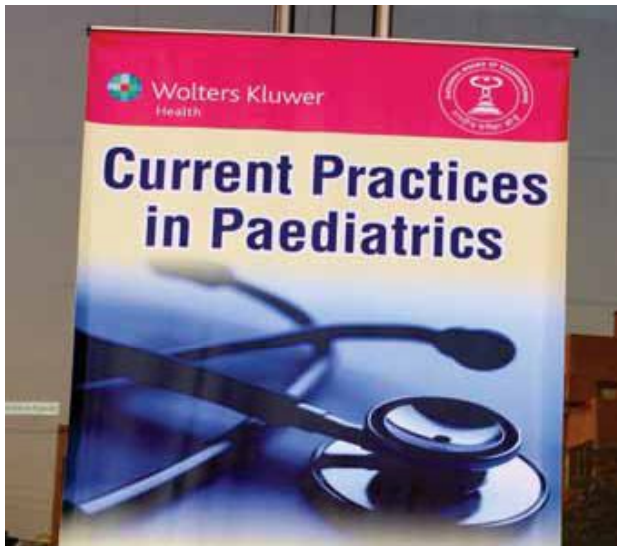

As per NBE norms, writing a thesis is essential for all DNB candidates towards partial fulfillment of eligibility for award of DNB degree certificate.

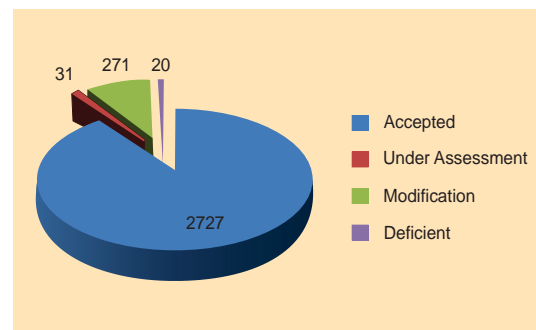

The members of the faculty guiding the thesis/dissertation work for the candidate to ensure that the subject matter selected for the Thesis /dissertation is feasible, economical and original.

DNB candidates are required to submit their thesis before the cut off date which shall be 30th June of same year for candidates appearing for their scheduled December final theory examination. Similarly candidates who shall be appearing in

their scheduled June DNB final examination shall be required to submit their thesis by 31st of preceding December.

(ii) PROTOCOL

The protocol for a research proposal is a study plan, designed to describe the objectives, background, methodology, organization, the participants, interventional procedures and assessment tools of the trial.

Preparation of the Thesis Protocol by the candidate helps him in understanding the ongoing research activities in his area of interest. Further it helps in creating practical exposure to research and hence it

bridges the gap between clinical practice and biomedical research.

As per NBE prescribed guidelines candidate should submit thesis protocol within 3 months of joining DNB institute. The candidate should refer to the Thesis Protocol Guidelines as provided by NBE for writing protocols.

During the Year 2013-14, 1948 fresh protocols were received for assessment out of which 853 have been assessed.

A. SIGNIFICANT ACCOUNTING POLICIES (ILLUSTRATIVE)

The National Board of Examination is established by the Govt. of India in the Ministry of Health and Family Welfare in the year 1975 and it became an independent autonomous body with effect from March, 1982. The Rules and Regulations of the Board have been framed by the central Govt. The Board at present conducts postgraduate and postdoctoral examinations all over the country. It awards its own degree known as Diplomat of National Board which are equivalent to MD/MS/DM/Mch of other Indian Universities as recognized by the Govt. of India and are included in the First Schedule of the Indian Medical Council Act 1956. The Board since its inception follows by and large the financial policies as laid down by the Central Govt. Almost all the revenue and capital expenditure is being met out from its own generated fund. This is non-profit making organization. The Accounts of the Board are audited by the Comptroller and Auditor General of India.

1. The financial statements are prepared on cash basis including interest of FDRs accounted for when it's matured or renewed.
2. The Board is an autonomous body and has been created by the Govt. of India. All the receipts and payments are accounted for in government pattern and as such Income Tax is not payable on the savings.
3. Revenue from students as examination fee, enrollment fee, FMGE, sale of application form etc. is recognized when received.
4. Fixed assets are stated at cost of acquisition inclusive of inward freight, duties and taxes related to acquisition less depreciation thereon.
5. Annual Prize Fund has been created by donations received from various High Dignitaries for award of Gold Medals in various specialties. The income on account of interest is added to fund and expenditure made is reduced from the fund itself. It is liability on the Board.
6. Liability towards pension and gratuity payable on death/retirement of employees is accrued based on actuarial valuation.
7. All deposits are made in the Nationalized Banks.
8. Previous year's figures are regrouped, rearranged wherever necessary.



9. Depreciation is charged on fixed assets at the rates prescribed under the Income tax act, 1961 on written down value, except land including leasehold land on which no depreciation is to be provided.
10. The amount given by the various hospitals/ medical colleges for their accreditation is booked as advance until the accreditation is approved. After the approval, the same is booked as income of the Board.

B. NOTES TO ACCOUNTS

1. An Amount of Rs 16, 51, 25,000/- received from various Hospital/Medical colleges during the year 2013-14 for granting their accreditation has been booked under "other current Liabilities". The amount will be adjusted in the next financial year after the decision of the approval of their accreditation is finalized.

Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of National Board of Examinations for the year ended 31 March 2014

We have audited the attached Balance Sheet of National Board of Examinations as at 31 March 2014, the Income & Expenditure Account and Receipts & Payments Account for the year ended on that date under Section 20(1) of the Comptroller and Auditor General's (Duties, Powers & Conditions of Service) Act, 1971. The audit has been entrusted for the period up to 2017-18. These financial statements are the responsibility of the Board's management. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This Separate Audit Report contains the comments of the Comptroller and Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards and disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any, are reported through Inspection Reports/CAG's Audit Reports separately.

3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. A.1.1 Provisions: ₹ 45.14 Crore

Provision for gratuity and leave encashment as required in the common format of accounts for the central autonomous bodies was not made on actuarial basis.

A.2 Assets

A.2.1 Fixed Assets: ₹ 78.91 Crore

Leasehold land of ₹ 1.24 crore was not amortized over the period of lease resulting in understatement of expenditure and overstatement of fixed assets. The period of lease was not intimated to audit as a result the amount of amortization could not be worked out.

B. Grants-in-aid

The Ministry of Health and Family Welfare sanctioned Nil grant during 2013-14. The Board had its own receipt of ₹ 95.95 crore out of which ₹ 86.81 crore was utilized leaving a balance of ₹ 9.14 crore as on 31st March 2014.

v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income and Expenditure Account and Receipts and Payments Account dealt with by this report are in agreement with the books of accounts.

vi.
