Xerox copies of Audited Balance Sheets, ITR, P & L A/c statement and a certificate in this regard is to be submitted duly certified by a Chartered Accountant.</p> <p>5. Experience of Similar Work: The Bidder should have experience of providing Security Services during last 3 years, as mentioned under:</p> <p>i) Three similar completed works costing not less than the amount equal to 40% of the estimated cost, or</p> <p>ii) Two similar completed works costing not less than the amount equal to 50% of the estimated cost, or One similar completed work costing not less than the amount equal to 80% of the estimated cost.</p>
