### General Terms and conditions for sale of old diesel staff cars of NBEMS

- 1. The disposal of staff car(s) shall be strictly on "As is Where is" basis and no guarantee or certificate of its worthiness or quality will be given by the NBEMS.
- 2. Bidders need to submit earnest money for INR 20000.00. The earnest money can be deposited by Pay Order/Demand Draft/Banker's Cheque in favor of "National Board of Examinations in Medical Sciences, New Delhi". The demand draft should be attached with the quoted bid, failing which the bids will not be considered at all. If the highest Bidder/ successful Bidder fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.
- 3. Offers received without EMD amount shall not be considered at all by NBEMS.

- 7. The sold staff car(s) will be removed by the successful bidder(s) by depositing the money at their own expenses. No assistance / transportation will be provided by the NBEMS. Permission to take out the disposed staff car(s) from the premises will be allowed only on working days.
- 8. The successful bidder will also be responsible for getting the Registration Certificate of the staff car(s) transferred in his name at his own cost expeditiously in the concerned RTO. - 9. NBEMS reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.

#### General Terms and conditions for sale of old diesel staff cars of NBEMS

- 11. The bidder is required to reveal his full name / name of authorized signatory of the firm / name of father, full postal address, telephone number and mobile number.
- 12. If the highest quoting firms fail to honor the bid, the contract will be cancelled and its EMD will be forfeited.
- 13. Tendering forms should be signed in ink by the authorized signatory only, photocopy or unsigned or not signed by authorized signatory shall be rejected.
- 14. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
- 15. The evaluation of the bid will be done on individual staff car basis in respect of all three (03) old diesel staff cars excluding all leviable taxes. However, the bid quoted should not be less than the rate fixed by the NBEMS in any case.
- 16. The staff car(s) can be reused or scrapped as per successful bidder's choice. However, the concerned bidder has to mention the purpose of (whether to scrap or for reuse) each staff car.
- 17. For scrapping the staff car, successful bidder has to follow the following directions:
  - a. A "Scrapping Certificate" must be submitted by the successful bidder before taking any of the staff car.
  - b. The staff car identification plate (the one that has the engine and chassis numbers engraved on it, successful bidder might need someone to use a blowtorch and cut it out with its surrounding metal) shall be removed and handed over to NBEMS before taking away the staff car(s).
- 18. For reuse of the staff car(s), successful bidder has to follow the following directions:
  - a. The process of transfer of ownership has to be completed by the successful bidder at his own cost which should be exclusive of bid amount.
  - b. The staff car(s) will be handed over to successful bidder only after he submits the proofs and documents of transfer of ownership.
- 19. The successful bidder will be liable to pay the applicable 18% GST on the auction sale price.
